Minutes of the Crakehall with Langthorne Parish Council meeting on Wednesday, 21 May 2025 at Crakehall Village Hall at 7:20pm, following the Annual Parish Meeting

1. Apologies for Absence

Apologies for absence were received from Councillor Stirke, and North Yorkshire Council Councillor Weighell.

2. Councillors' Declarations of Acceptance of Office

The Clerk reported that subject to the Standing Orders, this item was not necessary to complete as all standing councillors had already completed their declarations of acceptance upon election/co-option.

3. Councillors' Registrations of Interest

The Clerk encouraged councillors to ensure they keep their registrations updated.

4. Election of Chairman and Declaration of Acceptance of Office

Resolved: That Councillor Shaw be elected as Chair of the Parish Council, proposed by Councillor Wilson and seconded by Councillor Ventham.

5. Election of Vice-Chairman and Declaration of Acceptance of Office

Resolved: That Councillor Randall be elected as Vice-Chair of the Parish Council, proposed by Councillor Wilson and seconded by Councillor Ventham.

6. Co-option of Parish Councillor

The Clerk reported that due to the vacancy of a parish councillor position, the council was able to co-opt a councillor to the position. It was reported that two candidates had submitted applications to the council and it was resolved that:

• Elaine Buckley would be co-opted as a Parish Councillor.

Cllr Buckley signed her Declaration of Acceptance and joined the meeting.

7. Selection of Representatives

It was resolved that the following Councillors would be appointed as the council's representatives to the following bodies:

8. Cemetery Report

The Chair presented the Cemetery Report for the year 2024/25 and noted that the cemetery had received in total £665 over the year, and that this was lower than expected, however following the council's budgetary decisions fees had been increased in August 2025 and would be maintained at the new rate for 2025/26, with the expectation that income would increase.
