The work to the **railings outside St Edmund's** had now been completed by NYCC (some 33 months after the damage occurred)!

NYCC had confirmed recently that they are installing a post at the **new layby on the A684** just outside the village to accommodate one of the "**Take Your Litter Home**" signs provided by Hambleton District Council. A second sign will be fixed to railings near the play equipment on The Batts.

The **gate post on the footpath between Crakehall Mill and Green Gate Lane** had not yet been repaired although a fairly secure

temporary gate had been put in place. In the absence of clarity about ownership, **the council will undertake the repairs** although support towards material and labour will be sought from NYCC.

Yorkshire Water and NYCC (Highways) had both confirmed that the **open drain on Green Gate Lane** was not their responsibility, more likely it was the land owner's. Councillors agreed that this was not a parish council responsibility either.

Cllr Shaw reported the latest data from the **Vehicle Activated Sign** on the A684 with 85th percentile speeds in Little Crakehall as 32.9 mph from Leyburn and 32.9 mph towards Leyburn.

A request for **40 mph "buffer zones"** at either end of the village on the A684 had been submitted to NYCC but had been rejected but Councillors will pursue matters further.

In response to the **Annual Play Park inspection** reports Cllr Shaw had examined the **Bench Seat on The Batts** which was reported as having "2 corroded steel legs/feet creating instability". **Cllr Shaw** felt that only one leg required strengthening – he **volunteered to do the work himself**.

Quotes had been received for minor works to equipment at The Batts and at The Village Hall but both were felt to be excessively expensive for work to resolve very low risk issues. **Cllr Neale agreed to examine the surface underneath the swings at the Village Hall** and instal rubber matting if he felt it appropriate.

Celebrations were planned in both Crakehall and Langthorne for **The Queen's Platinum Jubilee from 2 to 5 June 2022** and the council agreed to buy **Jubilee Mugs for all children** living in the Crakehall and Langthorne parishes (aged 16 or under). Other residents will also be invited (via Facebook and this newsletter) to pre-order mugs for the "at cost" price of around £3 / mug. The council also agreed to waive the costs of hiring the **council's marquee for the event in Langthorne** on 5 June 2022 and to receive the donations from the **Langthorne community to purchase a seat for the village green**. The council also agreed to contribute £250 to **Bedale Town Council** to support financially the events they are planning in Bedale Park on Sunday 5th June.

Councillors noted the success of the **Wildflower Meadow** last summer and agreed to use the same seed and the same quantities again this year. Attempts will also

be made to plant seed on the grass bank between the road bridge and the footbridge.

A request had been received to site a **memorial bench in cemetery**. Councillors agreed the request but with the usual conditions.

Councillors discussed at length **damage caused by large delivery lorries to grass verges outside Langthorne Hall and speeding tractors in Langthorne**. The clerk had written to the companies concerned and NYCC had installed a plastic post and reinstated the grass. It was agreed that the clerk should also write to the owner of Langthorne Hall about the matter. As far as speeding tractors are concerned, residents are advised to take a note of the vehicle registration numbers and contact the police.

Road closed signs and bollards remain on the verges at either end of Langthorne village many months after the road through the village was closed for a few days. The clerk was asked to contact Highways to request their removal.

As the peak growing season was approaching, Cllr Stirke commented that she hoped that all local farmers would “spray out” any crops on **public footpaths** on their land so that **access was maintained**.

The next **Parish Council Elections** are **scheduled to take place on Thursday 5 May 2022** along with North Yorkshire County Council Elections. All seats on the parish council will become vacant.

The council raised no objections to the **Cricket Club's plan** to purchase sight screens and wicket covers and noted the intention to store these to the side of the pavilion when not in use. The council also noted that the **Emmerdale match** has been scheduled for 14 August 2022 (raising funds for Yorkshire Air Ambulance

A resident had suggested that the council should offer to “take some families” from Ukraine and, whilst this was not felt to be possible, the council was pleased to endorse the **“Homes for Ukraine” scheme**.

Cllr Wilson advised that some of the stones on the top of the walls of the **road bridge on the A684** appeared to have been dislodged by a vehicle. The clerk will contact Highways.

Concerns were raised again about **branches from trees on The Batts overhanging the bridge wall** (on the downstream side). An inspection was awaited.
